My years as a Mayor Protem and City Councilwoman in the 19th most populated city within Michigan, and earning my Masters in Finance DURING my 4-year term, gave me an eye-opening earth shattering wealth of knowledge and experience of how government REALLY operates. (90 words) RETIREE HEALTH BOND: I wholeheartedly disagree with bonding out the retiree healthcare and the building maintenance. Why would we go into MORE debt to pay for health care? Business cannot "bill" the taxpayers, our children, grandchildren, and great-grandchildren for the rise in costs, the county should not either. There are lots of humane alternatives that we used in closed session negotiations in SCS—we looked at those who retired earning \$50,000 or more knowing they could absorb a slight increase in their co-pay. This and other humane adjustments saved the SCS citizens \$250,000.

(62 words) IMPROVEMENT BOND: I also disagree with bonding out any building improvements. There are financial planning tools we can use like a Sinking Fund to pay for upgrades. It entails monthly/ annually putting aside money or "sinking" money into an account to be used for expensive projects. This way you have the money in the bank beforehand to complete the project without going into debt.

(130 words) WATER AUTHORITY: After sitting in many TIFA (Tax Increment Finance Authority) meetings and other government meetings, I am very leery of any government "Authority" group. Decisions for expenditures are taken out of the city's authority, out of direct public scrutiny, and are way out of control. Captured tax money is spent idiotically, contractors are lined up with nice but unnecessary projects that would make them a quick buck, and even though the meetings are open to the public, only 2 out of 60,000 SCS residents have the time to come and to hold them accountable. And if residents do try to hold them accountable, the people are belittled, told they do not know what they are talking about, steamrolled, or told to move out of the city if they don't like it.

(89 words) BLUE ECONOMY: I have difficulties with using hard earned taxpayer dollars for projects that business people don't find viable if they built it on their own. My city has been toying with the idea of a hotel but NOBODY has jumped up and done it---because it is not a viable project! So why should we be manipulating the economy in this way? It makes no sense to waste money this way if businesses are not going to fully bear the risk of the costly project without any subsidies/citizen tax dollars.
